**RELEASE AND REASSIGNMENT OF  
TRADEMARKS AND TRADEMARK APPLICATIONS**

January 9, 2018

Reference is hereby made to (i) that Intellectual Property Security Agreement, dated as of December 30, 2011, executed by Audyssey Laboratories, Inc., a Delaware corporation, ("**Grantor**"), in favor of Comerica Bank, a Texas banking association ("**Secured Party**"), which was recorded in the United States Patent and Trademark Office (the "**USPTO**") on January 4, 2012, at Reel 4691 Frame 0178 (the "**Initial Agreement**"); and (ii) that certain Intellectual Property Security Agreement, dated as of December 30, 2011, executed by Grantor, in favor of Secured Party, which was recorded in the USPTO on July 22, 2013, at Reel 5075 Frame 0433 (the "**Subsequent Agreement**", and together with the Initial Agreement, collectively, the "**Agreements**"), and pursuant to which the Grantor assigned and granted to Secured Party a security interest in and to all of Grantor's right, title and interest in and to certain trademarks, including those trademarks specifically listed on Exhibit A attached hereto (the "**Trademarks**") and the goodwill associated therewith; and

WHEREAS, Secured Party wishes to terminate the Agreement and release, retransfer and reassign to Grantor, or its successor in interest, without representation or warranty, all of Secured Party's right, title and interest in and to the Trademarks and the goodwill associated therewith;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby terminates the Agreement and releases, retransfers and reassigns to Grantor, or its successor in interest, without representation or warranty, any and all liens, security interests, right, title and interest of Secured Party in and to the Trademarks and the goodwill associated therewith.


