RELEASE OF SECURITY GRANT IN TRADEMARKS

This Release of Security Grant In Trademarks ("Release") is made effective as of January 11, 2018, by Boston Private Bank & Trust Company (the "Bank"), to LP Innovations, Inc., a Delaware corporation (the "Grantor"), as follows:

WHEREAS, pursuant to that certain Loan and Security Agreement (the "Security Agreement"), dated as of January 29, 2016, the Grantor granted to the Bank a security interest in certain trademarks and service marks listed on the annexed Schedule I as security for loans and other obligations;

WHEREAS, pursuant to the Security Agreement, the Grantor and the Bank entered into a Notice of Grant of Security Interest in Trademarks, dated as of January 29, 2016 (the "Security Grant"), pursuant to which the Grantor provided notice of its grant to the Bank of a continuing security interest in and continuing lien upon the trademarks and trademark applications shown in Schedule I (the "Trademarks");

WHEREAS, the Security Grant was recorded in the United States Patent and Trademark Office on February 4, 2016, at Reel 5724 / Frame 0272 (Trademarks);

WHEREAS, the Bank wishes to release its security interest in the Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby agrees as follows:

1. Release. The Bank hereby, without warranty as to status of title or priority of the encumbrances being hereby released, releases, discharges, terminates and cancels all right, title and interest in, to and under the Trademarks, including, without limitation, any security interest it may have in the Trademarks and the goodwill of the business connected with the use of, and symbolized by, the Trademarks, and retransfers and reassigns any and all right, title, and interest it may have in the foregoing without recourse to the Grantor.
2. Termination. The Bank, without any recourse, statement, representation and warranty, promise or undertaking whatsoever, hereby terminates and cancels the Security Agreement.
3. Further Assurances. At the request and expense of the Grantor, the Bank hereby agrees to perform all other and further acts, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to retransfer and reassign any and all right, title and interest it may have in the Trademarks without recourse to the Grantor.
