The Administrative Agent hereby agrees to take all further actions, and provide to the Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor and at Grantor's expense to more fully and effectively effectuate the purposes of this release or to reflect of public record the consummation of the termination and release contemplated by this release.
