**TERMINATION AND RELEASE OF SECURITY INTEREST**

This TERMINATION AND RELEASE OF SECURITY INTEREST is made as of January 25, 2018 by SILICON VALLEY BANK, a California corporation, with a loan production office located at 275 Grove Street, Suite 2-200, Newton, Massachusetts 02466 (“Bank”) in favor of DIALOGIC (US) INC. (Delaware), DIALOGIC INC. (Delaware), DIALOGIC US HOLDINGS INC. (Delaware), DIALOGIC DISTRIBUTION LIMITED (Ireland), DIALOGIC MANUFACTURING LIMITED (Ireland), DIALOGIC CORPORATION (Canada), and DIALOGIC GROUP, INC. (Canada), (are referred to herein, each and together, jointly and severally, as “Dialogic”) with offices located at c/o Dialogic (US) Inc., 4 Gatehall Drive, Parsippany, New Jersey 07054.

RECITALS

WHEREAS, Dialogic and Bank entered into Intellectual Property Security Agreement dated as of June 29, 2015 and a First Supplement to Intellectual Property Security Agreement dated as of October 31, 2016 (collectively, the “Security Agreement”);

WHEREAS, the Intellectual Property Security Agreement dated as of June 29, 2015 was recorded at the Patent Division of the U.S. Patent and Trademark Office on June 30, 2015 at Reel No. 036037 and Frame No. 0165, and recorded with the Trademark Division of the U.S. Patent and Trademark Office on June 30, 2015 at Reel 005564 and Frame No. 000935, and placed on file with the Trademark Division of the Canadian Intellectual Property Office on July 16, 2015; and a First Supplement to Intellectual Property Security Agreement dated as of October 31, 2016 was recorded at the Patent Division of the U.S. Patent and Trademark Office on November 1, 2016 at Reel No. 040542 and Frame No. 0297;

WHEREAS, pursuant to the Security Agreement, among other things, Dialogic granted to Bank a security interest in certain collateral, including the Specified Collateral (as hereinafter defined);

WHEREAS, Dialogic has no outstanding obligations to Bank under the terms of the Security Agreement with respect to the Specified Collateral, Bank agrees to release its security interest in the Specified Collateral;

WHEREAS, Bank now desires to terminate, release and discharge its security interest in the Specified Collateral;

AGREEMENT

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank agrees as follows:

1. DEFINITION. The term “Specified Collateral” as used herein, shall mean all of Dialogic’s right, title, and interest of every kind and nature as of the date hereof in the patents and trademarks and registrations thereof as set forth on Exhibits A and B hereto.

2. RELEASE OF SECURITY INTEREST. Bank hereby terminates, releases, and discharges its security interest in the Specified Collateral and reassigns to Dialogic, without representation, warranty, or recourse of any kind or nature, all interest of Bank in the Specified Collateral.
