**RELEASE OF SECURITY INTEREST IN  
TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this "Release") is dated as of January 26, 2018 by BANK OF AMERICA, N.A., as Agent (the "Secured Party"), in favor of THE PASHA GROUP ("TPG"), PASHA AUTOMOTIVE SERVICES ("Pasha Automotive"), and HAWAII STEVEDORES, INC. ("Hawaii Stevedores" and collectively with TPG and Pasha Automotive, the "Debtors").

**WITNESSETH**

WHEREAS, the Debtors and certain of their affiliates, as borrowers, the financial institutions party to the Agreement (as defined below) from time to time, as lenders, and the Secured Party entered into that certain Loan and Security Agreement, dated as of May 11, 2015 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Agreement");

WHEREAS, pursuant to the Agreement, (i) TPG executed and delivered to the Secured Party that certain Memorandum and Notice of Security Interest in Intellectual Property, dated as of May 11, 2015 (the "TPG Notice of Security Interest") and recorded with the United States Patent and Trademark Office ("USPTO") on May 14, 2015 at Reel/Frame No. 5517/0048, (ii) Pasha Automotive executed and delivered to the Secured Party that certain Memorandum and Notice of Security Interest in Intellectual Property, dated as of May 11, 2015 (the "Pasha Automotive Notice of Security Interest") and recorded with the USPTO on May 14, 2015 at Reel/Frame No. 5517/0041, and (iii) Hawaii Stevedores executed and delivered to the Secured Party that certain Memorandum and Notice of Security Interest in Intellectual Property, dated as of October 9, 2015 (the "Hawaii Stevedores Notice of Security Interest") and collectively with TPG Notice of Security Interest and Pasha Automotive Notice of Security Interest, the "Notices of Security Interest") and recorded with the USPTO on October 14, 2015 at Reel/Frame No. 5645/0572, pursuant to which the Debtors granted to the Secured Party, a security interest in and to all of their right, title and interest in and to the Trademarks (as defined in the applicable Notice of Security Interest), including the trademark registrations shown on Schedule I, attached hereto and incorporated herein by reference;



NOW, THEREFORE, in consideration of the foregoing, the Secured Party hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in the Trademarks and the trademark registrations set forth in Schedule I, and agrees that the security interest upon the Trademarks and such trademark registrations is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Debtors, without recourse, representation or warranty, any and all right, title and interest that the Secured Party may have obtained in, to and under the Trademarks and such trademark registrations under the Agreement and the Notices of Security Interest.
