**TERMINATION AND RELEASE OF PATENTS, TRADEMARKS AND COPYRIGHTS
SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF PATENTS, TRADEMARKS AND COPYRIGHTS SECURITY AGREEMENT (this "Termination"), is dated as of February 1, 2018, and made by **PNC BANK, NATIONAL ASSOCIATION** (the "Grantee"), to **SUPPLYONE, INC.**, a Delaware corporation, and **VIKING-CRITERION CORPORATION**, a New York corporation, (each a "Grantee", and collectively the "Grantors").

WHEREAS, pursuant to that certain Patents, Trademarks and Copyrights Security Agreement dated as of December 30, 2004 made by Grantors in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantors to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on January 31, 2005 at Reel/Frame 003021/0214, on January 31, 2005 at Reel/Frame 003021/Frame 0186, on October 7, 2005 at Reel/Frame 003205/0467 and on October 11, 2005 at Reel/Frame 003173/0374; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Trademarks," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Trademarks listed on Schedule A hereto

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks.
