**TERMINATION AND RELEASE OF AMENDED AND RESTATED PATENTS,
TRADEMARKS AND COPYRIGHTS IP SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF AMENDED AND RESTATED PATENTS, TRADEMARKS AND COPYRIGHTS IP SECURITY AGREEMENT (this "Termination"), is dated as of February 1, 2018, and made by **PNC BANK, NATIONAL ASSOCIATION** (the "Grantee"), to **SUPPLYONE, INC.**, a Delaware corporation, **SUPPLYONE NEW YORK, INC.**, a New York corporation, and **SUPPLYONE ROCKWELL, INC.**, a Virginia corporation (each a "Grantee", and collectively the "Grantors").

WHEREAS, pursuant to that certain Amended and Restated Patents, Trademarks and Copyrights IP Security Agreement dated as of July 20, 2007, made by Grantors in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantors to Grantee in certain collateral, including the Intellectual Property (as hereinafter defined);

WHEREAS, the Security Agreement was recorded at the trademark division of the United States Patent and Trademark Office on August 2, 2007 at Reel/Frame 003593/0259 and at the patent division of the United States Patent and Trademark Office on August 2, 2007 at Reel/Frame 019636/0769; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Intellectual Property," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Intellectual Property listed on Schedule A hereto

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Intellectual Property and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Intellectual Property.
