## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “*Release*”) is made as of the 20th day of February, 2018 by Merion Investment Partners II, L.P., a Delaware limited partnership located at 555 East Lancaster Avenue, Suite 500, Radnor, Pennsylvania 19087 (“*Lender*”).

WHEREAS, reference is made to that certain Trademark Security Agreement, dated as of March 13, 2015 (the “*Trademark Security Agreement*”), by Sayers Technology, LLC, a Delaware limited liability company (“*Borrower*”), located at 815-A Brazos Street, #533, Austin, Texas 78701, in favor of Lender, which was recorded with the United States Patent and Trademark Office on March 13, 2015 in the trademark assignment records under reel/frame number 005477/0600; all capitalized terms used herein but not otherwise defined herein shall have the meanings assigned thereto in the Trademark Security Agreement or in the Note Purchase Agreement identified therein; and

WHEREAS, pursuant to the Trademark Security Agreement, Borrower granted Lender a security interest in all of the right, title and interest of Borrower in and to the Trademarks and related collateral identified therein, including but not limited to the Trademarks described on Schedule A hereto.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby irrevocably and forever releases and terminates its security interest in and to the Trademarks and related collateral arising under the Trademark Security Agreement, including, without limitation, the Trademarks identified on Schedule A hereto. Further, Lender understands and agrees that this Release may be recorded by or for Borrower with the United States Patent and Trademark Office and any other similar office or

agency throughout the world. Lender also agrees to execute any other documents and take any further action reasonably necessary in any jurisdiction that Borrower may reasonably require to effect the intent and purpose of this Release.

This Release shall be governed by and construed in accordance with the laws of the Commonwealth of Pennsylvania without regard to conflicts of law principles.


