## **RELEASE OF PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENT**

This Release of Patent, Trademark and Copyright Security Agreement ("Release") is made effective as of February 27, 2018, by PNC BANK, NATIONAL ASSOCIATION in its capacity as Agent for the Lenders (the "Administrative Agent"), to AMERICAN BRIDGE COMPANY, a Delaware corporation; AMERICAN BRIDGE CANADA COMPANY, a Canadian corporation; AMERICAN BRIDGE HOLDING COMPANY, a Delaware corporation; AMERICAN BRIDGE MAINTENANCE SERVICES COMPANY, a Delaware corporation; AB MAINTENANCE SERVICES USA COMPANY, a Delaware corporation; AMERICAN BRIDGE INTERNATIONAL CORPORATION, a Delaware corporation; and AMERICAN DOCK & TRANSFER COMPANY, a Delaware corporation (collectively, the "Pledgors"), as follows:

WHEREAS, pursuant to that certain Credit Agreement (the "Credit Agreement"), dated as of June 30, 2017, the Pledgors granted to the Administrative Agent a security interest in intellectual property as security for loans and other obligations;

WHEREAS, pursuant to the Credit Agreement, the Pledgors and Administrative Agent entered into a Patent, Trademark and Copyright Security Agreement, dated as of June 30, 2017 (the "Security Agreement"), pursuant to which the Pledgors granted to the Administrative Agent a security interest in the entire right, title and interest of the Pledgors in and to all of the Pledgors' Patents, Trademarks and Copyrights (as such term is defined in the Security Agreement) including the trademarks set forth in Schedule A hereto;

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on July 5, 2017, at Reel 6099 / Frame 0017 (Trademarks);

WHEREAS, the Administrative Agent wishes to release its security interest in the Patents, Trademarks and Copyrights.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Release. The Administrative Agent hereby, without warranty as to status of title or priority of the encumbrances being hereby released, releases, discharges, terminates and cancels all right, title and interest in and to the Patents, Trademarks and Copyrights, including, without limitation, any security interest it may have in the Patents, Trademarks and Copyrights and the goodwill of the business connected with the use of, and symbolized by, the Patents, Trademarks and Copyrights, and retransfers and reassigns any and all right, title, and interest it may have in the foregoing without recourse solely as to the Pledgors.

2. Termination. The Administrative Agent, without any recourse, statement, representation and warranty, promise or undertaking whatsoever, hereby terminates and cancels the Security Agreement as to the Patents, Trademarks and Copyrights.

3. Further Assurances. At the request and expense of the Pledgors, the Administrative Agent hereby agrees to perform all other and further acts, and provide to the Pledgors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgors to retransfer and reassign any and all right, title and interest it may have in the Patents, Trademarks and Copyrights without recourse to the Pledgors.
