## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "*Termination and Release*") is granted as of February 28, 2018 by (i) SILICON VALLEY BANK (the "*Bank*") in favor of (ii) JUSTRIGHT SURGICAL, LLC, a Colorado limited liability company, (the "*Grantor*").

**WHEREAS**, the Grantor executed and delivered an Intellectual Property Security Agreement dated as of June 3, 2016 (as amended, modified or supplemented prior to the date hereof, the "*Agreement*"; capitalized terms used but not defined herein shall have the meaning ascribed to them in the Agreement), granting the Bank a security interest in and lien on, among other things, certain Trademarks, including, without limitation, the trademarks and trademark applications described on Exhibit A attached hereto and made a part hereof;

**WHEREAS**, the Agreement was recorded in the United States Patent and Trademark Office ("*USPTO*") on June 08, 2016, at Reel 5808, Frame 0748;

**WHEREAS**, the Grantor has requested that the Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the Intellectual Property Collateral of Grantor, including, without limitation, the Trademarks; and

**WHEREAS**, the Grantor has requested that the Bank provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its security interests in the Trademarks described in the Agreement.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby releases, cancels, terminates and discharges any and all liens and security interests in each Grantor's right, title and interest in, to and under the Intellectual Property Collateral, including, without limitation, the Trademarks, and all goodwill associated therewith, described in the Agreement. Bank agrees that it shall, and at any Grantor's, or its respective successor's or assign's, reasonable request, execute, acknowledge and deliver to such Grantor all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.
