RESOLVED, that Article I of the Articles of Incorporation of this corporation shall be amended to read as follows:

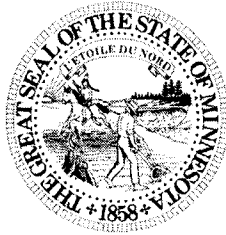
Article I
