**RELEASE OF SECURITY INTEREST IN

THIS RELEASE OF SECURITY INTEREST IN CERTAIN U.S. TRADEMARKS AND TRADEMARK REGISTRATIONS (this "*Trademark Release*") dated as of February 28, 2018, from BANK OF AMERICA, N.A., in its capacity as administrative agent (the "*Administrative Agent*") pursuant to a Security Agreement (the "*Security Agreement*") dated as of August 27, 2013 among CECO ENVIRONMENTAL CORP., a Delaware corporation (the "*Company*"), EACH SUBSIDIARY OF THE COMPANY FROM TIME TO TIME PARTY THERETO, and the Administrative Agent.

WITNESSETH:

WHEREAS, pursuant to the Security Agreement, a security interest (the "*Security Interest*") was granted by MPC Inc., a Delaware corporation (the "*Grantor*"), to the Administrative Agent in certain collateral, including the Specified Trademark Collateral (as hereinafter defined); and

WHEREAS, a Notice of Grant of Security Interest in Trademarks, dated as of August 27, 2013, was recorded in the Trademark Division of the United States Patent and Trademark Office on August 27, 2013 at Reel 5098, Frame 0846, including those trademarks and trademark applications set forth on Schedule I attached hereto; and

WHEREAS, the Administrative Agent has agreed to release its Security Interest in the Specified Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:


1. Definitions. The term "*Specified Trademark Collateral*", as used herein, shall mean the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks and trademark registrations described on Schedule I attached hereto.

2. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges its Security Interest in the Specified Trademark Collateral described on Schedule I hereto and any goodwill connected with the use thereof and symbolized thereby; any royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect thereto; and any claims and causes of action with respect hereto, whether occurring before or after the date hereof, all without representation, warranty or recourse of any kind or nature.
