RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (“*Release*”) is made and effective as of February 28, 2018, by WILMINGTON SAVINGS FUND SOCIETY, FSB, in its capacity as successor collateral agent to Bank of America, N.A., (the “*Collateral Agent*”) for its own benefit and the secured parties under the Security Agreement (defined below) (the “*Secured Parties*”).

WITNESSETH:

WHEREAS, the Sports Authority, Inc., TSA Stores, Inc., TSA Gift Card, Inc., and Slap Shot Holdings Corp. (collectively “*TSA*”) and other parties entered into that certain Intellectual Property Security Agreement dated as of May 3, 2006 in favor of Collateral Agent and recorded in with the United States Patent and Trademark Office on May 16, 2006 at Reel/Frame 3309/0786 and a certain Intellectual Property Security Agreement Supplement dated as of November 16, 2010, in favor of Collateral Agent and recorded with the United States Patent and Trademark Office November 18, 2010 at Reel/Frame 4408/0098 (the “*Intellectual Property Security Agreement*”);

WHEREAS, Collateral Agent, on the one hand, and TSA, on the other hand, are parties to that certain Intellectual Property Security Agreement Supplement, dated as of January 27, 2016, which incorporated by reference the Intellectual Property Security Agreement identified above (the “*Security Agreement*”), pursuant to which TSA pledged and granted a lien and security interest to Collateral Agent (for its own benefit and the benefit of the other Secured Parties) in, *inter alia* certain trademark registrations and applications, and the goodwill associated therewith, set forth on Exhibit A attached hereto and made a part hereof (those trademark registrations and applications listed on Exhibit A the “*Trademarks*” for the purposes of this document); and


WHEREAS, the Collateral Agent recorded the security interest in said Trademarks under the Security Agreement with the Assignment Division of the United States Patent and Trademark Office on January 28, 2016 at Reel 5717, Frame 0943.

NOW THEREFORE, in consideration for the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Security Interest. Collateral Agent, on behalf of itself and the Secured Parties, their successors, legal representatives and assigns, hereby terminates the Security Agreement and releases and discharges any and all collateral pledges, grants, assignments, liens and security interests that is has in and to the Trademarks pursuant to the Security Agreement and any and all right, title and interest it may have in and to the Trademarks originally granted to the Secured Parties pursuant to the Security Agreement, in each case without warranty or recourse.
2. Further Assurances. Collateral Agent agrees to take all further actions and such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as TSA and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.
