RELEASE OF SECURITY INTEREST (INTELLECTUAL PROPERTY)

THIS RELEASE OF SECURITY INTEREST having an effective date of March 16th, 2018 by Bank of America, N.A., individually as secured party for its own account, and/or as administrative agent for secured parties under the Security Agreements (as defined below) (collectively, in all such capacities, "Secured Party"), is in favor of LDRV Holdings Corp., a Delaware corporation, Lazy Days' R.V. Center, Inc., a Delaware corporation, Lazydays Arizona, LLC, a Delaware limited liability company, Lazydays Land Holdings, LLC, a Delaware limited liability company, and Lazydays Tampa Land Holdings, LLC, a Delaware limited liability company (collectively, "Assignors").

WHEREAS, Assignors and Secured Party entered into certain security agreements dated on or around November 18, 2015; November 18, 2013; April 26, 2011; October 20, 2010; December 22, 2009; November 11, 2009; and February 22, 2007 (as such may have been amended, supplemented or otherwise modified from time to time, collectively, the "Security Agreements"), under which Assignors granted to Secured Party a security interest in intellectual property collateral, including but not limited to the trademarks, trademark applications, copyrights and copyright applications listed on Exhibit A attached hereto;

WHEREAS, Assignor has requested that Secured Party release its continuing security interest as to the intellectual property listed on the attached Exhibit A, as well as to any other intellectual property subject to a security interest as a result of any of the Security Agreements or any other security agreement securing floor plan obligations that may now exist, or may have ever existed, between any Assignor and Secured Party (collectively, the "IP Collateral");

WHEREAS, Secured Party desires to assign, release, terminate, discharge, grant, convey, deliver and transfer to Assignors its continuing security interest in all of the IP Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Secured Party hereby terminates, releases and discharges fully its lien on, and security interest in and to, all of the right, title and interest of Assignors in, to and under the IP Collateral, and any rights and goodwill associated therewith, granted pursuant to the Security Agreements.
