TERMINATION AND RELEASE OF SECURITY AGREEMENT

This TERMINATION AND RELEASE effective as of December 20, 2017 from ACF FinCo I LP, a Delaware limited partnership ("Lender") to Lifespan Brands LLC, a Delaware limited liability company (the "Borrower").

WITNESSETH:

WHEREAS Lava Lite LLC, a Delaware limited liability company, executed a Loan and Security Agreement with Keltic Financial Partners II, LP, a Delaware limited partnership ("Keltic Financial"), on September 9, 2011 ("Loan Agreement") and pursuant to said Loan Agreement executed a Patent and Trademark Security Agreement on September 9, 2011 ("Keltic Financial Security Agreement"), which was recorded in the United States Patent and Trademark Office at Trademark Reel 004620 Frame 0382 and Patent Reel 026883 Frame 0762 (the Loan Agreement and the Keltic Financial Security Agreement collectively referred to as the "Loan Documents");

WHEREAS pursuant to the Loan Documents, a security interest ("Security Interest") was granted by Lava Lite LLC to Keltic Financial in the Trademarks and Patents (as defined in the Keltic Financial Security Agreement) including without limitation those United States trademark registrations, trademark registration applications, patents, and patent applications listed on Schedule I hereto (collectively, the "Released Collateral");

WHEREAS Keltic Financial and Lender executed an Assignment of Security Interests in Intellectual Property Collateral as of June 4, 2014 whereby Keltic Financial assigned the Loan Documents and the Security Interest to Lender ("Security Assignment Agreement"), which was recorded in the United States Patent and Trademark Office at Trademark Reel 005483 Frame 0495 and Patent Reel 034924 Frame 0259;

WHEREAS Lava Lite LLC changed its name to Lifespan Brands LLC on January 29, 2016, which was recorded at Trademark Reel 5737 Frame 0076;

WHEREAS the Lender now desires to terminate and release the entirety of its Security Interest in the Released Collateral under the Security Assignment Agreement and the Loan Documents;

NOW THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Released Collateral pursuant to the Security Assignment Agreement and the Loan Documents, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Lender hereby states as follows:


