**RELEASE OF SECURITY INTEREST
IN PATENTS AND TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS (this "Release") is made effective as of March 21, 2018, by BOKF, NA dba Bank of Texas (the "Secured Party") in favor of SHOCKWATCH, INC., a Nevada corporation ("Debtor").

WHEREAS, the Debtor has granted security interests to the Secured Party under the Patent Security Agreement and Trademark Security Agreement, each dated as of February 24, 2011 (such Patent Security Agreement and Trademark Security Agreement, collectively, as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Debtor granted the Secured Party, among other collateral as set forth therein, a security interest in and lien on the trademarks and patents identified on Exhibit A hereto (the "IP Collateral");

WHEREAS, the granting of the security interest in the IP Collateral was recorded with the United States Patent and Trademark Office against the IP Collateral on March 8, 2011 at Reel number 4492 and Frame number 0925, and at Reel number 025918 and Frame number 0736; and

WHEREAS, the Debtor has requested that the Secured Party terminate and release its security interests in and liens on the IP Collateral.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1) Definitions. All capitalized terms not defined in this Release shall have the respective meaning given to them in the Security Agreement.

2) Termination and Release of Security Interest. The Secured Party hereby terminates, releases, and discharges its security interest in and liens on the IP Collateral, including, without limitation, the trademarks and patents listed on Exhibit A hereto, and the Secured Party hereby assigns and transfers to the Debtor, without representation, warranty or recourse, all of the Secured Party's right, title and interest in and to such trademarks and patents, effective as of the date set forth above.
