## **RELEASE OF PATENT AND TRADEMARK SECURITY AGREEMENT**

This Release of Patent and Trademark Security Agreement (this "Release"), effective March 26, 2018, is granted by Bank of America, N.A., a national banking association ("BoA"), in favor of Moroni Feed Company, a Utah corporation, and its successors, assigns, and legal representatives ("MFC").

### **Recitals**

WHEREAS, pursuant to that certain Loan and Security Agreement, dated March 16, 2012, by and between BoA, MFC, and Norbest, Inc., a Utah corporation, MFC and BoA executed that certain Patent and Trademark Security Agreement, dated March 16, 2012 (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, MFC pledged and granted to BoA a security interest in certain Patents and Trademarks as defined in the Security Agreement;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office at Reel/Frame 004742/0507 on March 23, 2012; and

WHEREAS, MFC has requested that BoA execute this Release in order to effectuate, evidence, and record the release and reassignment to MFC of any and all right, title, and interest BoA may have in MFC's Patents and Trademarks pursuant to the Security Agreement.

### **Release**

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, BoA hereby states as follows:

1. Release of Security Interest. BoA hereby terminates the Security Agreement and terminates, releases, and discharges any and all security interests that it has pursuant to the Security Agreement in any and all right, title, and interest in and to all of the Patents and Trademarks of MFC, including, without limitation, the trademarks listed on Schedule A attached hereto.

2. Further Assurances. BoA agrees, at MFC's expense, to take all further actions and to provide to MFC all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as MFC may reasonably request in order to confirm, effectuate, or record this Release.

3. Governing Law. This Release and any claim, controversy, dispute, or cause of action (whether in contract or tort or otherwise) based upon, arising out of, or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the State of Utah without giving effect to any conflict of law principles (but giving effect to federal laws relating to national banks).

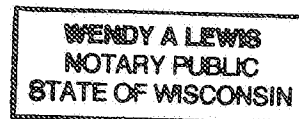
