Moger Avenue, Mount Kisco, New York 10549, hereby grant to **SECOND AVENUE CAPITAL PARTNERS, LLC**, a Delaware limited liability company with offices at 75 Second Avenue, Suite 550, Needham, MA 02494 (in its capacity as lender and together with any successors in such capacities, the "Grantee"), a continuing security interest in (i) all of each Grantor's, as applicable, right, title and interest in, to and under the trademarks, service marks, trade names, business names, trade styles, trade dress, logos, or other source of business identifiers, designs and general intangibles of similar nature, now existing or hereafter adopted or acquired, (collectively the "Marks") and all trademark registrations and trademark applications filed with respect thereto filed in the United States Patent and Trademark Office set forth on Schedule A attached hereto, (ii) all rights and privileges arising under applicable law with respect to the Grantor's use of such Marks, (iii) renewals, supplements and extensions thereof, (iv) income, fees, royalties, damages, claims and payments now or hereafter due and/or payable with respect thereto, including, without limitation, damages and payments for past, present or future infringements thereof, (v) rights corresponding thereto throughout the world, (vi) the goodwill of the businesses with which the Marks are associated, (vii) all causes of action and

rights to sue, whether arising prior to or after the date hereof, for infringement of any of the Marks or unfair competition regarding the same, and (viii) all proceeds and products of the foregoing (collectively the “Trademark Collateral”).

THIS GRANT (this “Grant”) is made to secure the satisfactory performance and payment of all the Obligations of each Grantor, as such term is defined in that certain Loan and Security Agreement dated as of April 25, 2018 (as amended, restated, supplemented or otherwise modified and in effect from time to time, the “Loan Agreement”) by and between the Grantors and the Grantee. The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Loan Agreement all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Loan Agreement, the provisions of the Loan Agreement shall govern.

This Grant of Security Interest in the Trademark Collateral shall be released upon the payment and performance of the Grantors’ obligations under the Loan Agreement, whereupon the Grantee shall execute all documents, make all filings, and take all other actions reasonably requested by the Grantors to evidence and record the release of the security interests in the Trademark Collateral granted herein.


