**PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Partial Release") is made as of May 1, 2018 ("Effective Date") by **JPMORGAN CHASE BANK, N.A.**, as administrative agent ("Administrative Agent") in favor of **CEB INC.**, a Delaware corporation, **EVANTA VENTURES, INC.**, a Delaware corporation, and **SOFTWARE ADVICE, INC.**, a California Corporation (each a "Grantor" and, collectively, the "Grantors").

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement by and among Administrative Agent, and the Grantors, dated April 5, 2017 (the "Trademark Security Agreement"), each Grantor granted to Administrative Agent a security interest in and to all of such Grantor's right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement), including the United States trademark registrations set forth on Schedule A attached hereto (such scheduled registrations, the "Released Trademarks"), in each case, together with the goodwill associated therewith;

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 24, 2017 at Reel 6040, Frame 0826; and


**WHEREAS**, Administrative Agent has agreed to terminate, cancel and release any and all security interests it has solely in the Released Trademarks.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby terminates, cancels and releases any and all security interests it has in the Released Trademarks, and hereby re-assigns, conveys and transfers to the Grantors any right, title and interest that the Administrative Agent may have in the Released Trademarks.

Nothing herein is, or shall be deemed, a termination, cancellation, release or other modification of Administrative Agent's security interests or liens on any of the Trademark Collateral other than the Released Trademarks. Except as to the Released Trademarks, the security interests and liens of Administrative Agent in the Trademark Collateral (including all other Trademark Collateral listed on Schedule A to the Trademark Security Agreement) shall continue in full force and effect as if this Partial Release had not been provided.
