NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

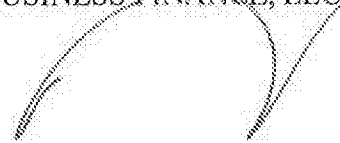
1. Agent hereby releases its security interest in all of Grantor's right, title and interest in and to the Collateral and Trademarks, including those trademarks set forth on Schedule A.
