NOTICE OF RELEASE OF  
SECURITY INTEREST IN TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), effective as of May 22, 2018 is made by PNC Bank, National Association, in its capacity as agent for the Lenders (as hereinafter defined) (together with its successors and assigns in such capacity, "Agent") in favor of Preventure, LLC (the "Grantor") pursuant to that certain Revolving Credit, Term Loan and Security Agreement date November 29, 2016 (as amended to date, the "Credit Agreement") among Grantor, certain of its affiliates, the lenders from time to time party thereto (the "Lenders"), and Agent.

W I T N E S S E T H:

WHEREAS, in connection with the Credit Agreement, the Grantor executed and delivered a Trademark Security Agreement, dated as of January 18, 2018, in favor of the Agent (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor pledged and granted to the Agent for the benefit of the Agent and the Lenders a continuing security interest in all of its trademarks and rights with respect thereto, including but not limited to the trademark registrations set forth on Schedule A attached hereto (the "Released Trademarks");

WHEREAS, the Agent recorded its security interest in the Released Trademarks in the United States Patent and Trademark Office on January 29, 2018 at Reel 6259 Frame 0790;

WHEREAS, the Agent now desires to terminate and release the entirety of its security interest in the Released Trademarks;

WHEREAS, the Agent has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent agrees, for the benefit of the Grantor, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Credit Agreement, as applicable.

SECTION 2. Release of Security Interest. The Agent does hereby release, relinquish and discharge its security interest in, and right of setoff against, all of the Grantor's right, title and interest in, to and under the Released Trademarks and all right, title and interest of the Grantor in the Released Trademarks are hereby reassigned by the Agent to the Grantor.
