**FIRST AMENDMENT TO
GRANT OF SECURITY INTEREST IN TRADEMARKS AND PATENTS**

B. Schedule A-2 to the Grant of Security Interest is hereby amended and restated in the form attached to this Amendment as Schedule A-2.

C. Schedule B-1 to the Grant of Security Interest is hereby amended and restated in the form attached to this Amendment as Schedule B-1.

D. Schedule B-2 to the Grant of Security Interest is hereby amended and restated in the form attached to this Amendment as Schedule B-2.

3. Miscellaneous.

A. No inference in favor of, or against, any party will be drawn from the fact that such party has drafted any portion of this Amendment, the Grant of Security Interest, or any other Loan Document, as each may be amended.


B. This Amendment may be executed in any number of counterparts, each of which will be deemed to be an original but all of which taken together will constitute one and the same agreement. Delivery of an executed counterpart of a signature page of this Amendment by facsimile or in electronic (i.e., “pdf” or “tif”) format shall be effective as delivery of a manually executed counterpart of this Amendment.

C. This Amendment will be governed by and construed under the laws of the State of Illinois.

D. This Amendment will be binding upon and will inure to the benefit of the parties hereto and to their respective successors and assigns.
