

Agent hereby authorizes the Grantors or the Grantors' authorized representative or designee to record this Termination and Release with the USPTO or any similar office or agency.
- Further Assurances. Upon request by the Grantors, the Agent hereby agrees to duly execute, acknowledge and deliver any further documents and to do such other acts as may be reasonably necessary to effect the termination and release of the Security Interest contemplated hereby.
