## **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of June 1, 2018, and made by **PNC BANK, NATIONAL ASSOCIATION**, in its capacity as Collateral Agent under the below-defined Security Agreement, having an office at 1900 East Ninth Street, 9th Floor, Mail Stop B7-YB13-09-5, Cleveland, OH 44114 ("Grantee") to Fairmount Santrol Inc., a Delaware corporation, Self-Suspending Proppant LLC, a Delaware limited liability company, TechniSand, Inc., a Delaware corporation, FML Resin, LLC, an Ohio limited liability company, Black Lab LLC, an Ohio limited liability company, and FML Sand, LLC, an Ohio limited liability company (collectively, "Grantors").

WHEREAS, pursuant to that certain Pledge and Security Agreement dated as of November 1, 2017 and that certain Trademark Security Agreement dated as of November 1, 2017 (as it may be amended, restated, supplemented or otherwise modified from time to time), made by Grantors in favor of Grantee (the "Security Agreement"), a security interest and continuing lien was granted by the Grantors to Grantee in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on November 6, 2017, at Reel 6197 and Frame 0654; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall have the meaning set forth in the Security Agreement and shall include all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.


2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademark Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest Grantee may have obtained in the Trademark Collateral.

3. Further Assurances. The Grantee shall take all further reasonable actions, and provide to Grantors and their successors, assigns or other legal representatives, all such reasonable cooperation and assistance (including, without limitation, the execution and delivery of documents and instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Termination, at the sole cost and expense of Grantors.
