RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY


WHEREAS, pursuant to that certain **FIRST AMENDMENT AND JOINDER TO SECURITY AGREEMENT** dated as of May 6, 2016 (the "Security Agreement") by and between **TEXAS CAPITAL BANK, NATIONAL ASSOCIATION**, a national banking association ("Secured Party") and **HIGHLAND LAKES ACQUISITION, LLC**, a Delaware limited liability company, **XTREME MARINE CORPORATION**, a Delaware corporation, **MARINE ACCESSORIES CORPORATION**, an Arizona corporation, **GREAT LAKES BOAT TOP LLC**, a Delaware limited liability company, **MONSTER MARINE PRODUCTS, INC.**, a Delaware corporation, **MARINE ACCESSORIES EUROPE B.V.**, a private limited liability company (*besloten vennootschap met beperkte aansprakelijkheid*), incorporated under the laws of the Netherlands, with its corporate seat in Warmond, the Netherlands, and **MARINE ACCESSORIES EUROPE HOLDCO, LLC**, a Delaware limited liability company (collectively, "Pledgors"), recorded in the Assignment Recordation Branch of the United States Patent and Trademark Office ("PTO") on May 11, 2016 at Reel/Frame 038676/0530 and Reel/Frame 5790/0604, Pledgors granted to Secured Party a security interest in and lien upon all of Pledgors' right, title and interest in and to the Intellectual Property Collateral described therein, including without limitation the trademarks and patents identified on the attached Schedule A, together with the goodwill of Pledgors' business symbolized by the Intellectual Property Collateral and all actions for infringement concerning the foregoing including the right to sue for past, present and future infringements (collectively, the "Intellectual Property Collateral"); and

WHEREAS, Secured Party wishes to provide a document suitable for recording in the Assignment Recordation Branch of the PTO for purposes of recording the release, relinquishment and discharge of its security interest in the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreement in all right, title and interest of Pledgors, and reassigns to Pledgors all right, title and interest that it may have, in and to the Intellectual Property Collateral, including without limitation the trademarks and patents identified on the attached Schedule A, without representation or warranty of any kind whatsoever.
