RELEASE OF TRADEMARK SECURITY AGREEMENT

This Release of Trademark Security Agreement (the “**Release**”) is made and effective as of June 21, 2018 and granted by Webster Bank, National Association (the “**Administrative Agent**”), in its capacity as administrative agent on behalf of Secured Parties (as defined in the Trademark Security Agreement described below) and in favor of Skyline Buyer, Inc. f/k/a Skyline Tent Company, a Delaware corporation (the “**Debtor**”).

WHEREAS, on November 2, 2017 the Debtor collaterally assigned to the Administrative Agent a security interest (the “**Trademark Security Agreement**”) in all of Debtor’s right, title and interest in, to and under the trademarks and trade names identified in Schedule A attached hereto (the “**Intellectual Property**”) which was recorded with the United States Patent and Trademark Office on November 29, 2017 at Reel/Frame 6214/0786.

WHEREAS, the Administrative Agent has agreed to release its security interest in the Intellectual Property and terminate such Trademark Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby states as follows:

1. Release of Trademark Security Interest. Administrative Agent hereby terminates the Trademark Security Agreement and terminates, releases and discharges any and all security interests that it has pursuant to the Trademark Security Agreement in any and all right, title and interest of the Debtor, and reassigns to the Debtor any and all right, title and interest that it may have, in or to the Intellectual Property.

2. Further Assurances. Administrative Agent agrees, at the Debtor’s expense, to take all further actions, and provide to the Debtor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Debtor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

3. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).
