## TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of June 15, 2018 by SILICON VALLEY BANK, as Administrative Agent (the “*Assignee*”), in favor of SPay, Inc., a Delaware corporation (“*SPay*”), Blue Star Sports Holdings, Inc., a Delaware corporation (“*Blue Star*”), Bonzi Technology Inc., an Oregon corporation (“*Bonzi*”), Pointstreak Inc., Delaware corporation (“*Pointstreak*”), and SDI Camps & Races, LLC, an Indiana limited liability company (“*SDI*”, together with “*SPay*”, “*Blue Star*”, “*Bonzi*” and “*Pointstreak*”, each individually and collectively, jointly and severally, the “*Grantor*”).

**WHEREAS**, the Grantor executed and delivered a Trademark Security Agreement, dated as of August 11, 2016 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Agreement*”), granting the Assignee a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on August 11, 2016, at Reel 5853, Frame 0009;

**WHEREAS**, SPay executed and delivered a First Supplement to Trademark Security Agreement, dated as of June 30, 2017 (the “*Supplement to Trademark Security Agreement*”, together with the Agreement, each a “*Grant*” and collectively, the “*Grants*”), granting the Assignee a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded with the USPTO on September 6, 2017, at Reel 6148, Frame 0466;

**WHEREAS**, Grantor has requested that Assignee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks (as defined in each respective Grant) (collectively, the “*Trademark Collateral*”) as herein provided; and

**WHEREAS**, Grantor has requested that the Assignee provide a document suitable for recording with the USPTO to evidence the release of the Assignee’s security interests in and liens on the Trademark Collateral as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:


1. terminates the Grants and releases, terminates and discharges all liens and security interests in Grantor’s right, title and interest in, to and under the Trademark Collateral, and all goodwill associated therewith, including those trademarks and trademark applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.

THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
