RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (this "Release"), dated as of June 25, 2018, is made by **MIDCAP FINANCIAL TRUST**, a Delaware statutory trust, in its capacity as Administrative Agent for the Lenders party to the Credit Agreement (as such terms are defined below) (together with its successors and assigns, "Grantee").

WHEREAS, Endocare, Inc., a Delaware corporation ("Grantor") granted a security interest in and lien upon certain trademarks and related rights owned by Grantor (the "Trademarks") in favor of Grantee for the benefit of the lenders (the "Lenders") party to that certain Credit and Guaranty Agreement dated March 8, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), which security interest and lien is set forth in that certain Trademark Security Agreement dated as of March 8, 2016, executed by Grantor, Grantee, and certain of the Credit Parties (the "Security Agreement"); and

WHEREAS, the Security Agreement, identifying the Trademarks set forth in Schedule A attached hereto, was recorded in the United States Patent and Trademark Office (the "USPTO") at Reel/Frame Nos. 005748/0781 on March 10, 2016; and

WHEREAS, pursuant to the terms of that certain Limited Consent and Release dated of even date herewith by and between Grantee, Lenders, Grantor and the parties signatory thereto as Credit Parties, Grantor and Credit Parties have requested that Grantee release the security interest and lien in the Trademarks; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee, on its own behalf and on behalf of the Lenders, hereby releases, relinquishes, and terminates any and all liens, security interests, or other interests in or rights it may have or has acquired through the Security Agreement in the Trademarks, including any rights it may have or has acquired in Trademarks that have been allowed to become abandoned or expire since the filing of the Security Agreement. Grantee shall cause an executed copy of this Release to be recorded at the USPTO. Unless otherwise defined herein, or the context otherwise requires, terms used in this Release, including its preamble and recitals, shall have the meanings ascribed to them in the Security Agreement.
