AMENDED AND RESTATED ASSIGNMENT FOR SECURITY – TRADEMARKS

WHEREAS, each of ARCHITECTURAL GRANITE & MARBLE, LLC, a Delaware limited liability company (“AG&M”), and PENTAL GRANITE AND MARBLE, LLC, a Washington limited liability company (“Pental” together with AG&M, each an “Assignor”), has adopted, used and is using, and holds all right, title and interest in and to, the trademarks and service marks listed on the attached Schedule A, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the “Trademarks”);

WHEREAS, each Assignor has entered into the Amended and Restated Loan, Security and Guaranty Agreement, dated June 28, 2018 (as may be amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Loan Agreement”), among Assignors, certain of Assignors’ Affiliates, and Bank of America, N.A., as the Lender (together with its successors and assigns, if any, the “Assignee”); and

WHEREAS, pursuant to the Loan Agreement, each Assignor has assigned to the Assignee and granted to the Assignee for the benefit of the Agent and each Lender a continuing security interest in all right, title and interest of such Assignor in, to and under the Trademarks, together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the “Collateral”), to secure the payment, performance and observance of the Obligations (as defined in the Loan Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Assignor does hereby pledge, convey, sell, assign, transfer and set over unto the Assignee and grants to the Assignee for the benefit of the Assignee and the Lenders a continuing security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations.

Each Assignor does hereby further acknowledge and affirm that the rights and remedies of the Assignee with respect to the Collateral are more fully set forth in the Loan Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

This Amended and Restated Assignment for Security – Trademarks constitutes an amendment, modification, restatement and replacement, but not an extinguishment or novation, of that certain Assignment for Security – Trademarks, dated February 28, 2017, from Assignor in favor of Assignee (“Original Trademark Security Agreement”). This Agreement is not intended as, and shall not be construed as a satisfaction, release or impairment of the agreements and obligations of Assignors under the Original Trademark Security Agreement or any document executed therewith. Assignor hereby agrees that, with respect to matters relating to the period prior to the date hereof, all provisions of the Original Trademark Security Agreement are hereby ratified and confirmed and shall continue in full force and effect, as amended and restated by this Amended and Restated Assignment for Security – Trademarks.


