TRADEMARK SECURITY RELEASE

THIS TRADEMARK SECURITY RELEASE (this "Release") is made as of June 29, 2018, by OAKTREE SPECIALTY LENDING CORPORATION (f/k/a FIFTH STREET FINANCE CORP.), a Delaware corporation, as the administrative agent for the Lenders as defined in that certain Loan and Security Agreement dated July 10, 2014, as amended (together with its successors and assigns, "Agent"), in favor of INTEGRAL DEVELOPMENT CORP., a California corporation, INFX II, LLC, a California limited liability company, INFX BROKERAGE LLC, a California limited liability company, INFX SEF, Inc., a Delaware corporation, and INFX SDR, Inc., a Delaware corporation (individually and collectively, jointly and severally, "Assignor").

WITNESSETH:

WHEREAS, reference is made to that certain Trademark Collateral Assignment and Security Agreement dated as of July 10, 2014, and recorded at the United States Patent and Trademark Office on July 15, 2014, at Reel 5322, Frame 0782 (the "Security Agreement"; capitalized terms which are not defined herein have the meanings given to such terms in the Security Agreement), pursuant to which Assignor granted to Agent for the benefit of Agent and the Lenders, a continuing security interest in the Trademarks (including among other things, the Trademark registrations and Trademark applications set forth on Exhibit A attached hereto; collectively, the "Trademark Collateral");

WHEREAS, Assignor has requested that Agent release its continuing security interest in the Trademark Collateral; and

WHEREAS, Agent has agreed to terminate and release the entirety of its continuing security interest in and to the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Agent hereby states as follows:

1. Agent hereby terminates, cancels, and releases its continuing security interest in all of Assignor's right, title, and interest in and to the Trademark Collateral.
2. Agent hereby releases and conveys to Assignor, without any representation, recourse or undertaking by Agent, any and all of Agent's right, title, and interest that it may have obtained in and to the Trademark Collateral, and does hereby authorize Assignor (personally or through its counsel, agents, or designees, and at Assignor's sole expense) to take all actions reasonably necessary to release and terminate any and all security interests and other liens in the Trademark Collateral. If and to the extent Agent has acquired any right, title, or interest to any of the Trademarks or the goodwill associated therewith, it hereby assigns and transfers such rights, title, or interest to Assignor.
3. Agent shall take all further actions, reasonably acceptable to Agent, and provide to Assignor and each of its successors, assigns, or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents

or other instruments), requested by Assignor, each at Assignor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.




