## **TRADEMARK ASSIGNMENT**

This Trademark Assignment (this “Assignment”), dated as of March 31, 2018, is by and between SOCIÉTÉ DES PRODUITS NESTLÉ S.A., a société anonyme organized under the laws of Switzerland (“Assignor”), and FERRARA CANDY COMPANY, an Illinois corporation (“Assignee”). Reference is made to that certain letter agreement regarding notice of assignment, dated as of the date hereof, by and between Ferrero International, S.A., a Luxembourg société anonyme (“FINT”), and Nestlé USA, Inc., a Delaware corporation (“Nestlé”) (an Affiliate of Assignor) (such notice, the “Assignment Notice”). Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such term in the AAA (as defined below) in the form attached as Exhibit A to the Assignment Notice.

**WHEREAS**, Nestlé and FINT have entered into that certain Asset Purchase Agreement, dated as of January 16, 2018 and amended on March 14, 2018 (as the same may be amended from time to time, the “Asset Purchase Agreement”), pursuant to which, and subject to the conditions set forth therein, FINT has agreed to purchase certain assets relating to the Business (as defined in the Asset Purchase Agreement);

**WHEREAS**, Assignor, Nestec S.A. (an Affiliate of Assignor) and FINT have entered into that certain Amended and Restated Intellectual Property Purchase Agreement, dated as of March 30, 2018 (as the same may be amended from time to time, the “Intellectual Property Purchase Agreement”), pursuant to which Assignor and Nestec S.A. have agreed to sell FINT the Transferred Intellectual Property (as defined in the Intellectual Property Purchase Agreement);

**WHEREAS**, in connection with the Closing of the transactions contemplated by the Asset Purchase Agreement and the Intellectual Property Purchase Agreement and pursuant to Section 11.6 of the Asset Purchase Agreement and Section 8.7 of the Intellectual Property Purchase Agreement, FINT has assigned to Assignee and certain of its other Affiliates, and each of Assignee and such other Affiliates has accepted from FINT, certain of FINT’s rights and obligations under the foregoing Asset Purchase Agreement and Intellectual Property Purchase Agreement by entering into that certain APA Assignment & Assumption Agreement, dated as of March 30, 2018 (the “AAA”);

**WHEREAS**, Assignor is the owner of the Trademarks included in the Sugar Purchased Intellectual Property, including the Trademarks set forth on Schedule A attached hereto and incorporated herein by reference (collectively, the “Sugar Purchased Trademarks”); and

**WHEREAS**, in connection with the transactions contemplated by the AAA, the Asset Purchase Agreement and the Intellectual Property Purchase Agreement and the Closing, Assignor desires to assign and transfer to Assignee all of Assignor’s right, title and interest in and to the Sugar Purchased Trademarks, together with all goodwill associated with the Sugar Purchased Trademarks, and Assignee desires to acquire from Assignor all such right, title and interest in and to the Sugar Purchased Trademarks.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign and transfer to Assignee, its successors and assigns, all of Assignor’s right, title and interest in and to the Sugar Purchased

Trademarks, together with all goodwill associated with said Sugar Purchased Trademarks, and all rights to sue and recover for, and all rights to profits or damages due or accrued, arising out of or in connection with any and all past, present or future infringements or dilution of or other violation or damage to any of the Sugar Purchased Trademarks or the associated goodwill.

Assignor further agrees that it will cause to be performed such other lawful acts, and to be executed such further assignments and other lawful documents, as Assignee may, from time to time, reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner of the Sugar Purchased Trademarks. Assignee shall be responsible for all fees for recordation of this Assignment, and Assignor agrees to cooperate fully with Assignee to accomplish such recordation.

This Assignment is being executed and delivered pursuant to, and is subject to and shall be governed by the terms and conditions of, the Intellectual Property Purchase Agreement. Nothing in this Assignment is intended to or shall be deemed to amend, modify, supplement, or limit in any manner any of the representations, warranties, covenants, agreements, rights, or obligations of Assignor, Nestec S.A. and FINT under the Intellectual Property Purchase Agreement. In the event of any conflict between the terms and conditions of this Assignment and the terms and conditions of the Intellectual Property Purchase Agreement, the terms and conditions of the Intellectual Property Purchase Agreement shall control.

All matters relating to the interpretation, construction, validity and enforcement of this Assignment shall be governed by and construed in accordance with the domestic laws of the State of New York without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction other than Section 5-1401 and Section 5-1402 of the General Obligations Law of the State of New York) that would cause the application of Laws of any jurisdiction other than the State of New York.


