**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of May 9, 2018, is made by and between **OAKTREE SPECIALTY LENDING CORPORATION**, a Delaware corporation, as agent (“Agent”), and **AVITA DRUGS, LLC** (the “Grantor”), a Louisiana limited liability company.

**RECITALS:**

WHEREAS, Grantor and Fifth Street Management LLC (“Resigning Agent”) are parties to that certain Amended and Restated Guaranty and Security Agreement, dated as of June 9, 2016 (as the same has been and may thereafter be amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), pursuant to which Grantor entered into that certain Trademark Security Agreement, dated as of June 9, 2016 (the “Trademark Security Agreement”) and granted to Resigning Agent a security interest in all of its right, title and interest in, to and under certain Trademark Collateral (as defined below);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 9, 2016, at Reel/Frame: 5812/0598;

WHEREAS, Resigning Agent and Agent entered into that certain Assignment of Trademark Security Agreement (the “Assignment Agreement”), effective as of October 17, 2017, pursuant to which Resigning Agent assigned and transferred to Agent and its successors and assigns, all of its rights, title and interest in and to the Trademark Security Agreement and the Trademark Collateral;

WHEREAS, the Assignment Agreement was recorded with the United States Patent and Trademark Office on November 6, 2017, at Reel/Frame: 6197/0481; and

WHEREAS, Grantor has requested and Agent has agreed to release its rights and security interests in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used herein but not otherwise defined have the meanings set forth in the Security Agreement.

2. Release of Security Interest. Agent hereby fully and finally terminates the Trademark Security Agreement and releases, without any representation, its security interest and rights in, to and under the following (collectively, the “Trademark Collateral”):

(a) all of the Grantor’s Trademarks and all IP Licenses providing for the grant by or to such Grantor of any right under any Trademark (“Trademark Licenses”), including, without limitation, those referred to on Schedule A hereto;

(b) all renewals or extensions of the foregoing, including the right to claim priority or file an application on the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and

(d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

3. Authorization. Agent hereby authorizes Grantor or Grantor's agent to record this Release with the United States Patent and Trademark Office
