LaSalle St., Chicago, Illinois 60603, pursuant to that certain Collateral Agreement dated as of July 16, 2015, by and among the grantors from time to time party thereto (each a "Grantor" and collectively, the "Grantors") and the Administrative Agent for the Secured Parties referenced therein (as the same may have been amended, modified, restated, or supplemented from time to time, the "Collateral Agreement"), does hereby unconditionally and expressly release, terminate and forever discharge and extinguish any and all of its right, title and interest in and to any and all liens and security interests it may have under all intellectual property collateral identified in the Collateral Agreement and the Notice of Grant of Security Interest in Trademarks dated as of July 16, 2015 among the Administrative Agent and the Grantors (the "Trademark Security Agreement"), including the trademarks listed on Exhibit A attached hereto (the "Released Collateral"), arising from the Collateral Agreement and the Trademark Security Agreement, which was recorded in the United States Patent and Trademark Office ("PTO") on or about July 16, 2015, against the United States trademarks listed on Exhibit A at Reel/Frame Numbers 005578/0304. 
