## RELEASE OF SECURITY INTEREST IN TRADEMARKS

RELEASE OF SECURITY INTEREST IN TRADEMARKS by Citizens Bank of Pennsylvania (“**Bank**”) to CRF Inc., a Delaware corporation, (“**CRF**”). Bank and CRF are hereinafter collectively referred to as the “**Parties**.”

**WHEREAS**, the Parties entered into a certain Loan and Security Agreement pursuant to which Bank agreed to extend to CRF a line of credit facility;

**WHEREAS**, in accordance with the terms of the Loan and Security Agreement, the Parties executed an Intellectual Property Security Agreement effective as of December 6, 2013, pursuant to which CRF granted to Bank a security interest in all of CRF’s right, title, and interest in and to the trademarks, service marks, and United States Trademark Applications and Registrations identified in Schedule A attached hereto (collectively, the “**Trademarks**”) to secure the payment, performance, and observance of the obligations created by the Loan and Security Agreement;

**WHEREAS**, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on December 13, 2003 at Reel 5173 / Frame 0569;


**WHEREAS**, CRF has discharged the obligations created by the Loan and Security Agreement and secured by the grant of the security interest in the Trademarks;

**WHEREAS**, CRF desires to obtain, and Bank desires to provide, a document suitable for recording in the United States Patent and Trademark Office the release, relinquishment, and discharge of the security interest in the Trademarks;

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by each party, Bank hereby releases, relinquishes, and discharges the security interest in the Trademarks granted by CRF in the Intellectual Property Security Agreement, and reassigns to CRF all right, title, and interest in and to the Trademarks.
