**TERMINATION AND RELEASE OF NOTICE OF GRANT OF SECURITY INTEREST  
IN TRADEMARKS**

**THIS TERMINATION AND RELEASE OF NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS** (this "Termination"), is dated as of April 2, 2018, and made by **PNC BANK, NATIONAL ASSOCIATION** (the "Grantee"), to **SHELL TOPCO LP**, a Delaware limited partnership, **WESCON PLASTICS, LLC**, formerly known as Wescon Plastics Acquisition Co., LLC, a Delaware limited liability company, **COAST WIRE & PLASTIC TECH, LLC**, formerly known as Coast Wire Acquisition Co., LLC, a Delaware limited liability company, **MC ELECTRONICS, LLC**, formerly known as MC Shell Acquisition Co., LLC, a Delaware limited liability company, and **ANDERSON & FORRESTER, LLC**, formerly known as A&F Acquisition Co., LLC, a Delaware limited liability (each a "Grantor" and collectively the "Grantors").

WHEREAS, pursuant to that certain Notice of Grant of Security Interest in Trademarks dated as of September 28, 2012, made by Grantors in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantors to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on October 1, 2012 at Reel/Frame 4870/Frame 0005; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Trademarks" as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Trademarks listed on Schedule A hereto

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks.
