## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”) is made as of June 29, 2018, by GOLDMAN SACHS SPECIALTY LENDING GROUP, L.P., in its capacity as collateral agent (“**Collateral Agent**”), in favor of JOHN GORE THEATRICAL MANAGEMENT GROUP, INC. (f/k/a KEY BRAND THEATRICAL MANAGEMENT GROUP, INC.) (“**Grantor**”).


**WHEREAS**, pursuant to (i) that certain Pledge and Security Agreement, dated as of August 8, 2013, by and among each of the Grantors party thereto and Collateral Agent and (ii) that certain Trademark Security Agreement, dated as of August 8, 2013 (the “**Security Agreement**”), executed by Grantor in favor of Collateral Agent and recorded in the records of the United States Patent and Trademark Office on August 8, 2013 at Reel/Frame 005088/0097—0104, Grantor granted to Collateral Agent a continuing security interest in all of Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined in the Security Agreement), including those trademarks set forth on Schedule A hereto.

**FOR GOOD AND VALUABLE CONSIDERATION**, the receipt and adequacy of which are hereby acknowledged, Collateral Agent hereby (a) terminates and releases all liens and security interests granted by Grantor in favor of Collateral Agent in the Trademark Collateral, (b) assigns, transfers and delivers to Grantor all of its right, title and interest in and to the Trademark Collateral to the extent that any such right, title and interest exists as of the date hereof and (c) terminates and cancels the Security Agreement. Collateral Agent hereby authorizes Grantor or their designee to make filings with the United States Patent and Trademark Office and take further actions necessary to evidence the release and termination of Collateral Agent’s security interests in the Trademark Collateral. Collateral Agent hereby authorizes the governing body of the United States Patent and Trademark Office to record this Release.
