## TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this "Agreement"), is dated as of May 31, 2018, and is among COOPERATIVE REGIONS OF ORGANIC PRODUCER POOLS, a cooperative association incorporated under Chapter 185 of the Wisconsin Statutes (the "Borrower"), OMC, LLC, a Wisconsin corporation ("OMC"), and ORGANIC LOGISTICS, LLC, a Wisconsin limited liability company ("OL"; the Borrower, OMC, and OL, each a "Grantor", and collectively, the "Grantors"), and acknowledged by JPMORGAN CHASE BANK, N.A., in its capacity as administrative agent (in such capacity, the "Administrative Agent") for the lenders party to the Credit Agreement referred to below (the "Lenders").

### RECITALS

A. The Grantors are party to that certain Credit Agreement, dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among the Grantors, the Administrative Agent, and the Lenders, pursuant to which the Lenders have agreed to make loans to the Borrower.

B. Pursuant to the Credit Agreement, the Grantors are required to execute and deliver to Lender this Agreement.

C. Pursuant to the terms of that certain Pledge and Security Agreement, dated as of the date hereof, by the Grantors in favor of the Administrative Agent, on behalf of the Lenders (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), each Grantor has granted to the Administrative Agent, on behalf of and for the ratable benefit of the Secured Parties (as defined in the Credit Agreement), a security interest in substantially all the assets of such Grantor, including all right, title and interest of such Grantor in, to, and under all now owned and hereafter acquired trademarks, trademark applications and trademark licenses, and all products and proceeds thereof, to secure the payment and performance of the Secured Obligations (as defined in the Credit Agreement).

### AGREEMENT

In consideration of the mutual agreements set forth herein, in the Credit Agreement and in the Security Agreement, each Grantor hereby grants to Administrative Agent, on behalf of and for the ratable benefit of the Secured Parties, a continuing security interest and lien in all of such Grantor's right, title and interest in, to, and under the following, whether presently existing or hereafter created or acquired to secure the payment and performance of the Secured Obligations:

- (1) each trademark and trademark application, including, without limitation, each trademark and trademark application referred to in Schedule 1 attached hereto and incorporated herein, together with any reissues, continuations or extensions thereof and all goodwill associated therewith;
- (2) each trademark license, including, without limitation, each trademark license listed on Schedule 1, together with all goodwill associated therewith; and
- (3) all products and proceeds of the foregoing, including, without limitation, any claim by such Grantor against third parties for past, present or future infringement of any trademark, including, without limitation, any trademark referred to in Schedule 1, any

trademark issued pursuant to a trademark application referred to in Schedule 1 and any trademark licensed under any trademark license listed on Schedule 1 (items 1 through 3 being herein collectively referred to as the "Trademark Collateral"). Notwithstanding the foregoing, any trademark applications filed in the United States Patent and Trademark Office ("PTO") on the basis of any Grantor's intent to use such trademark shall be excluded from Trademark Collateral, unless and until a statement of use or amendment to allege use is filed in the PTO, whereupon such trademark shall automatically be deemed included in the Trademark Collateral.


This security interest and lien is granted in conjunction with the security interests and liens granted to the Administrative Agent, on behalf of and for the ratable benefit of the Secured Parties, pursuant to the Security Agreement and subject to limitations set forth therein. Each Grantor hereby acknowledges and affirms that the rights and remedies of the Administrative Agent, on behalf of the Secured Parties, with respect to the security interests and liens in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. Capitalized terms used but not defined herein have the respective meanings ascribed thereto in the Credit Agreement or the Security Agreement, as appropriate. This Agreement is made under and shall be governed by the internal laws of the State of Illinois applicable to contracts made and to be performed entirely within such state, without regarding to conflict of laws principles thereunder.




