**THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this "Release") is made this 3<sup>rd</sup> day of August, 2018, by TEXAS CAPITAL BANK, NATIONAL ASSOCIATION, as Agent ("Agent").


