## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is entered into as of August 15, 2018 (the "Effective Date"), between MANUFACTURERS AND TRADERS TRUST COMPANY, in its capacity as Collateral Agent for the benefit of the Secured Parties (the "Collateral Agent"), and FIRST SOURCE, LLC (f/k/a Wythe Will Tzetzko, LLC), a Maryland limited liability company (the "Grantor").

WHEREAS, the Collateral Agent, for the benefit of the Secured Parties, previously was granted a security interest with respect to certain trademarks, as more particularly described in Exhibit A attached hereto (the "Trademark Collateral"), of the Grantor pursuant to a Trademark Security Agreement, dated as of May 18, 2018 (as amended, supplemented, reaffirmed, amended and restated or modified from time to time, the "Trademark Agreement"; any capitalized term used but not otherwise defined herein shall have the meaning assigned to such term in the Trademark Agreement), made by Grantor, in favor of the Collateral Agent, which agreement was recorded May 21, 2018, with the United States Patent and Trademark Office at Reel 6333, Frame 0630; and


WHEREAS, in connection with the full satisfaction and discharge of all obligations secured by the Trademark Agreement, the Grantor has requested that the Collateral Agent release its security interest granted pursuant to the Trademark Agreement in the Trademark Collateral, including all goodwill associated with the Trademark Collateral, and the Collateral Agent (acting on behalf of the Secured Parties) has agreed to do so on the terms and conditions set forth in that certain payoff letter executed by the Collateral Agent and the Grantor contemporaneously herewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent (acting on behalf of the Secured Parties) hereby (i) terminates, releases and discharges its security interest and all of its right, title and interests in, to and under the Trademark Collateral and all such right, title and interests are hereby reassigned to the Grantor without representation or warranty of any kind and (ii) authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Release.



