**RELEASE AND TERMINATION OF SECURITY INTEREST
IN PATENTS, TRADEMARKS AND COPYRIGHTS**

This RELEASE and TERMINATION, dated as of August 1, 2018, is made by FIDUS MEZZANINE CAPITAL, L.P. as Collateral Agent, 1603 Orrington Avenue, Suite 1005, Evanston, IL 60201 (hereinafter "Fidus").

WHEREAS, Jacob Ash Holdings, Inc. (the "Pledgor") and Fidus entered into a Grant of Security Interest in Patents and Trademarks (as amended, modified, restated or supplemented from time to time, the "IP Security Agreement") as of August 11, 2011 and recorded in the U.S. Patent and Trademark Office on December 30, 2014, at Reel 5432, Frame 0413; August 24, 2015 at Reel 5605, Frame 0586, August 24, 2015 at Reel 36422, Frame 0034 and December 30, 2014, at Reel 34603, Frame 0867 in which IP Security Agreement the Pledgor granted a security interest to Fidus in certain Patents and Trademarks and applications therefor that the Pledgor then owned. 
