**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of August 31, 2018, by **KEYBANK NATIONAL ASSOCIATION**, a United States national association), (the “Collateral Agent”) in favor of **AMPAC FINE CHEMICALS LLC**, a California limited liability with an address at 3883 Howard Hughes Parkway, Suite 700, Las Vegas, Nevada 89169 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a Grant of Security Interest in Trademarks (the “Trademark Security Agreement”) dated November 10, 2017 with the Collateral Agent, notice of which was recorded on August 3, 2018 at the United States Patent and Trademark Office at Reel 6405, Frame 0077.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.


