NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Administrative Agent hereby terminates the Agreement and releases, retransfers and reassigns to Pledgor without representation or warranty, any and all liens, security interests, right, title and interest of Administrative Agent in and to the Marks and the goodwill associated therewith and the Patents.
