RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of September 7, 2018 (the "Effective Date"), by MB FINANCIAL BANK, N.A., successor by merger to Cole Taylor Bank ("Grantee"), in favor of GREAT WESTERN CO., LLC, a Delaware limited liability company ("Grantor").

WHEREAS, pursuant to a Grant of Security Interest in Trademarks dated as of July 3, 2014 (the "Security Agreement"), from Grantor to Grantee, Grantor granted to Grantee a security interest in, and a lien upon, all of Grantor's right, title and interest in and to the trademarks, trademark registrations, trademark applications, and any and all goodwill associated therewith (the "Marks") set forth on Schedule A attached hereto, (ii) all Proceeds (as such term is defined in the Security Agreement) of the Marks, (iii) all of the goodwill of the businesses with which the Marks are associated, and (iv) all causes of action, past, present and future, for infringement, misappropriation, or dilution of any of the Marks or unfair competition regarding the same (all of the foregoing is, collectively, the "IP Collateral");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on July 9, 2014, at Reel 5319, Frame 0158; and


WHEREAS, Grantee desires to terminate the Security Agreement and release its security interest in the IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Grantee hereby unconditionally and expressly releases and terminates, and extinguishes any and all of its right, title and interest in and to, and any and all liens and security interests it may have upon, all of the IP Collateral.

This Release shall be binding upon Grantee's legal representatives, assigns and successors.

IN WITNESS WHEREOF, Grantee has caused this Release to be executed by its duly authorized representative as of the Effective Date.


