**TERMINATION AND RELEASE OF AMENDED AND RESTATED SECOND LIEN  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF AMENDED AND RESTATED SECOND LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "Termination"), is dated as of October 1, 2018 and made by **WILMINGTON TRUST, N.A.** as collateral agent, located at Rodney Square North, 1100 North Market Street, Wilmington, DE 19890 ("Collateral Agent") to **SIDEWINDER DRILLING LLC**, a Delaware limited liability company (the "Grantor"), located at 952 Echo Lane, Suite 460, Houston, TX 7024.

**WHEREAS**, pursuant to that certain Amended and Restated Second Lien Intellectual Property Security Agreement, dated as of February 15, 2017, made by Grantor in favor of the Collateral Agent (the "Second Lien IP Security Agreement"), a security interest was granted to the Collateral Agent in certain collateral, including the Collateral (hereinafter, as defined in the Second Lien IP Security Agreement);

**WHEREAS**, the Second Lien IP Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on February 22, 2017, at Reel 5995 and Frame 0298; and

**WHEREAS**, the Collateral Agent now desires to terminate and release the Second Lien IP Security Agreement;


**NOW, THEREFORE**, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Collateral Agent hereby states as follows:

1. Release of Security Interest. The Collateral Agent hereby terminates the Second Lien IP Security Agreement and terminates, releases and discharges its security interest in the Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of the Collateral Agent in the Collateral, including, without limitation, the trademarks listed on Schedule A hereto.
