TRADEMARK ASSIGNMENT

This Trademark Assignment (this "**Assignment**") is made effective October 1, 2018 by and between FMC Corporation, a Delaware corporation having its principal place of business at 2929 Walnut Street, Philadelphia, Pennsylvania 19104, United States of America ("**Assignor**"), and FMC Lithium USA Corp., a Delaware corporation having its principal place of business at 2929 Walnut Street, Philadelphia, Pennsylvania 19104, United States of America ("**Assignee**") and replaces and supersedes any other assignment of the Marks (as defined below) from Assignor to Assignee.

RECITALS

WHEREAS, pursuant to the Separation and Distribution Agreement between Assignor and Livent Corporation of even date herewith (the "**SDA**"), Assignor agreed to contribute, transfer and convey, and cause certain of its affiliates to contribute, transfer and convey, to Livent Corporation the Lithium Assets, including the Lithium Intellectual Property, on the terms and subject to the conditions contained in the SDA;

WHEREAS, as of the date of this Assignment, Assignee is a wholly-owned subsidiary of Livent Corporation; and

WHEREAS, as required by the SDA, Assignor desires to assign, transfer and convey to Assignee, and Assignee desires to acquire from Assignor, Assignor's right, title and interest in and to the Trademarks identified and set forth on Schedule A hereto (the "**Marks**"), together with all goodwill and other rights associated with the Marks.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Unless otherwise defined herein, all capitalized terms used herein shall have the meanings ascribed to such terms in the SDA.
2. The above recitals are incorporated herein as if set forth in full below.
3. Assignor hereby assigns, conveys, sets over and transfers to Assignee all of Assignor's right, title and interest in, to and with respect to the following:
 - a) The Marks and all issuances, extensions, and renewals thereof, together with all the goodwill of the business connected with the use of and symbolized by the Marks;
 - b) All common-law rights as well as any additional rights associated with the Marks in any jurisdiction; and
 - c) The right to recover damages for any and all past, present and future infringement, misappropriation, or other violation of rights upon or related to the Marks, if any.
4. Assignor agrees that, upon reasonable request by Assignee, Assignor and its successors and assigns will take reasonable actions, including the execution of papers and the giving of testimony, that may be necessary for Assignee to obtain and/or enforce any registration for such Marks and to perfect, record and/or maintain the title of Assignee, its

successors and assigns to such Marks and any registration(s) issued for such Marks. Assignor authorizes and requests the United States Commissioner of Patents and Trademarks and the officials of corresponding entities or agencies in any other applicable jurisdictions to record and register this Assignment to reflect Assignee as the assignee and owner of the Marks and to issue any and all registrations thereon to Assignee, as assignee of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of Assignee and its successors, assigns or other legal representatives.

5. Assignee hereby accepts the assignment and conveyance of the Marks.

6. The parties hereto acknowledge and agree that this Assignment is entered into pursuant to the SDA, to which reference is made for a further statement of the rights and obligations of Assignor and Assignee with respect to the Marks. The representations, warranties, covenants, agreements, and indemnities contained in the SDA shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the SDA and the terms hereof, the terms of the SDA shall govern.

7. EXCEPT AS PROVIDED IN THE SDA OR ANY OF THE ANCILLARY AGREEMENTS, THIS ASSIGNMENT CONTAINS NO EXPRESS OR IMPLIED REPRESENTATIONS OR WARRANTIES OF ANY KIND, INCLUDING THOSE REGARDING TITLE, NON-INFRINGEMENT, MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE OR REGARDING THE SCOPE, VALIDITY OR ENFORCEABILITY OF ANY OF THE MARKS.

8. This Assignment may be executed in two or more counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument. Delivery of an executed signature page to this Assignment by facsimile or other electronic transmission will be effective as delivery of a manually executed counterpart to this Assignment.

9. This Assignment shall be governed by and construed under the law of the State of New York, and all rights and remedies shall be governed by such laws, without regard to principles of conflicts of laws. This Assignment shall bind and inure to the benefit of the parties hereto and their respective successors and assigns. This Assignment may not be amended or otherwise altered except by a writing signed by both parties. The failure of Assignor or Assignee to enforce any terms hereunder shall not waive any of its rights under such term or provision.

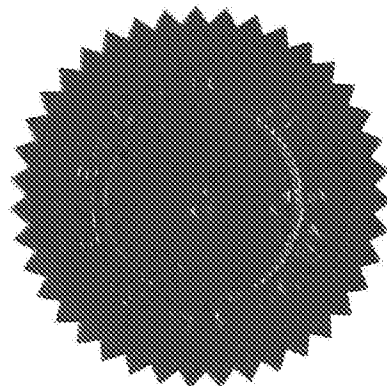

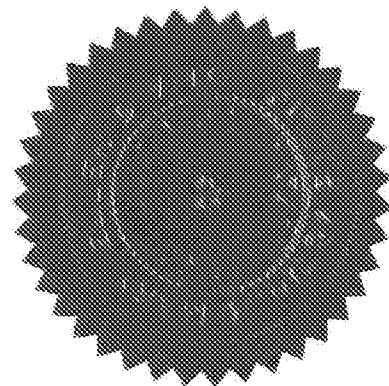
