1. Article First of the Corporation's Certificate of Incorporation is amended to read in its entirety as follows:

"First. The name of the corporation is Prince Agri Products, Inc."

2: Pursuant to the provisions of Section 242 of the Delaware General Corporation Law, the Board of Directors of the Corporation, acting pursuant to the provisions of Section 141 of the Delaware General Corporation Law, as of July 24, 2008, adopted a resolution setting forth the proposed amendment to the Certificate of Incorporation of the Corporation, declaring said amendment to be advisable, and calling a meeting of the stockholders of the Corporation for consideration thereof. Thereafter, the stockholders of the Corporation, acting pursuant to Section 228 of the Delaware General Corporation Law, by written consent in lieu of a meeting, dated as of July 24, 2008, adopted a resolution in favor of the aforesaid amendment. Said amendment was duly adopted in accordance with the provisions of Section 242 of the Delaware General Corporation Law.
