RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, SUPERVALU HOLDINGS, INC., a Missouri corporation (“Debtor”), granted a security interest in and lien upon certain trademarks and related rights to Goldman Sachs Bank USA, in its capacity as administrative agent (in such capacity, “Secured Party”) as set forth in the Grant of Security Interest in United States Trademarks, dated as of March 21, 2013, between Debtor and Secured Party (the “Trademark Security Agreement”);

WHEREAS, an executed copy of the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on March 25, 2013, at Reel 4990, Frame 0536;

WHEREAS, Debtor has requested that Secured Party release and reassign its interest in the trademarks granted in the Trademark Security Agreement, including the trademarks more fully identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

1. Releases and reassigns to Debtor any and all liens of Secured Party pursuant to the Trademark Security Agreement including any and all liens in (a) all of such Debtor’s right, title and interest in, to and under, all trademarks (including service marks), slogans, logos, certification marks, trade dress, uniform resource locations (URLs), domain names, corporate names and trade names, whether registered or unregistered, owned by or assigned to such Debtor and all registrations and applications for the foregoing (whether statutory or common Law and whether established or registered in the United States or any other country or group of countries or any political subdivision thereof), including, without limitation, the registrations and applications set forth on Schedule A attached hereto (the “Marks”), (b) all rights and privileges arising under applicable law with respect to such Debtor’s use of any Marks, (c) all reissues, extensions, continuation and renewals thereof, (c) income, fees, royalties, damages and payments now and hereafter due and/or payable thereunder and with respect thereto, including, without limitation, damages, claims and payments for past, present or future infringements thereof, (d) all of the Goodwill associated with any of the foregoing, (e) rights corresponding thereto throughout the world and (f) rights to sue for past, present and future infringements thereof; and

2. Authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.
