## TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION OF SECURITY INTEREST IN TRADEMARKS, dated as of November 7, 2018, is made by Citizens Bank, N.A. (formerly known as RBS Citizens, N.A.) (the "Secured Party").
