## RELEASE OF TRADEMARK SECURITY AGREEMENT

WHEREAS, by the Rider to Security Agreement – Trademarks dated March 16, 2016 (the “Security Agreement”), originally recorded in the Trademark Assignment database of the United States Patent and Trademark Office (“USPTO”) on March 18, 2016 at Reel 5753 Frame 0307, Market Planning Solutions, Inc., a Delaware corporation, Knowledge Support Systems, Inc., a New Jersey corporation, and MPSI International Inc., an Oklahoma corporation, (together, “Grantors”), granted to PNC Bank, National Association, a national banking association (“Releasor”), a continuing security interest in all of Grantors’ right, title and interest in the trademarks identified in Schedule A; and


