**Release of Security Interest in Trademarks**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of November 16, 2018 (this “Release”), is made by CANTOR FITZGERALD SECURITIES, as Collateral Agent (together with its successors and assigns in such capacity, the “Collateral Agent”), in favor of CAPELLA HEALTHCARE, LLC, a Delaware limited liability company, ESSENT HEALTHCARE, INC., a Delaware corporation, KERSHAW HOSPITAL, LLC, a South Carolina limited liability company, RCHP BILLINGS-MISSOULA LLC, a Delaware limited liability company, RCHP-FLORENCE, LLC, a Delaware limited liability company, RCHP-OTTUMWA, LLC, a Delaware limited liability company, RCHP – WILMINGTON, LLC, a Delaware limited liability company, REGIONALCARE HOSPITAL PARTNERS HOLDINGS, INC., a Delaware corporation, and WILLAMETTE VALLEY MEDICAL CENTER, LLC, a Delaware limited liability company (each a “Pledgor”). Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Collateral Agreement (as defined below). The rules of construction specified in Section 1.01(b) of the Collateral Agreement also apply to this Release.

**WHEREAS**, the Pledgors, the other pledgers party thereto and the Collateral Agent entered into (i) that certain Collateral Agreement (First Lien) dated as of April 25, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), , and (ii) that certain Trademark Security Agreement dated as of April 25, 2018 (the “Trademark Security Agreement”), pursuant to which each Pledgor granted and pledged to the Collateral Agent, its successors and permitted assigns, for the benefit of the Secured Parties, a security interest in all of such Pledgor’s right, title and interest in, to and under any and all of the following assets now owned or at any time hereafter acquired by such Pledgor or in which such Pledgor now has or at any time in the future may acquire any right, title or interest (collectively, but excluding any Excluded Property, the “Trademark Collateral”):

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 15, 2018, at Reel/Frame 6379/0958 (Capella Healthcare, LLC), at Reel/Frame 6374/0094 (Essent Healthcare, Inc.), at Reel/Frame 6374/0110 (Kershaw Hospital, LLC), at Reel/Frame 6373/0564 (RCHP Billings-Missoula LLC), at Reel/Frame 6385/0959 (RCHP-Florence, LLC), at Reel/Frame 6386/0756 (RCHP-Ottumwa, LLC), at Reel/Frame 6331/0314 (RCHP-Wilmington, LLC), at Reel/Frame 6331/0269 (RegionalCare Hospital Partners Holdings, Inc.) and at Reel/Frame 6331/0285 (Willamette Valley Medical Center, LLC); and

**WHEREAS**, the Collateral Agent has agreed to execute and deliver this Release to evidence the release of its security interest in the Trademark Collateral.

**NOW THEREFORE**, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, without any representation, warranty or recourse of any kind or nature, hereby terminates, cancels and releases its security interest in the Trademark Collateral, and hereby re-assigns, re-transfers

and re-conveys to each Pledgor (as applicable) any and all right, title and interest the Collateral Agent may have in or to the Trademark Collateral.


